Terms and Conditions

1. Categories of Memberships:

a) Life Members

i) On payment of Rs. 20,000/- in one lump sum, one shall become Life Member, The membership ceases with the life of the member. The Life Member shall have right to vote. Apart from the lump sum, the Life Member shall pay an annual subscription of Rs. 2500/-

ii) One membership card shall be issued and will entitle the Life Member free admission with upto 3 additional guests per visit.

b) Corporate Members

i) Companies, Firms, Trusts, Corporations, Societies, Association and Bodies Corporate can become corporate member on payment of a lump sum of Rs. 1,00,000/-. The authorized representative shall be entitled to attend the meeting with right to vote. Apart from the lump sum, the Corporate Member shall pay an annual subscription of Rs. 10,000/-.

ii) One membership card shall be issued and will entitle the Corporate Members free admission with upto 10 additional guests per visit.

c) All other Categories of Membership

i) Students of Schools/ Colleges are eligible to become a member on payment of subscription or Rs. 150/- per annum. The student members have neither right to vote nor eligible to any office of the Association.

ii) Any Indian National completing 18 years of age other than students can become Member on payment of Rs. 500/- per annum. The members shall have no right to vote and would not be eligible to any office of the Association.

iii) Any foreign national regardless of age can become a member on payment of 100 US \$ per annum. The foreign national has no right to vote nor eligible for any office of the Association.

iv) One membership card entitles one person only.

2. Each card can be used only Once in a day.

3. The card is non-transferable.

4. Membership Card will be requested at the entrance for verification.

5. Loss of Membership cards must be reported within 24 hours.

6. The membership card is the property of NBNP and shall be returned upon request. The management reserves the right to reject any application or renewal and to suspend or terminate a membership without liability or refund if any of the conditions of the membership are not complied with or upon abuse of privileges.

7. Non-payment of Annual Subscription 15 days prior to expiry of membership entails automatic cancellation of membership.
